**FINANCIAL REPORTS:**

**Parish Life Committee:** Bill Carle reported he has been contacted by the Girl Scouts about holding a fund-raising garage sale sometime in the Spring of 2022. After discussion, it was decided he will talk further with the leaders about the guidelines which will have to be followed and report back to the Vestry.

Fr. David Lynch reported that the First Friday events have not been well attended. The November 5<sup>th</sup> Bingo Night has been canceled. The December 3<sup>rd</sup> Movie Night and early 2022 events remain on the calendar.

**Communication Committee:** It was approved that Jim Gilligan ask for help in designing a new logo for the church. It will be used on letterhead, web page, etc.

**Emergency Planning Committee:** Fr. David Lynch reported the Diocese is stressing the need for each church to have a current emergency plan. Our plan is current as it was updated in March, 2021.

**Pastoral Care:** Fr. David Lynch reported that he continues to call on people, but is also honoring their space if they do not want an in-person visit.

**DISCUSSION/ACTION ITEMS:**
